## REPRODUCTION USE AGREEMENT

*In exchange for the one-time, non-exclusive use of reproductions of materials owned by Pasadena Museum of History, the user agrees to the following terms and conditions:*

1. User agrees to pay applicable use fees in advance by cash, check or credit card to Pasadena Museum of History (see fee schedule below).
2. User agrees to pay additional fees separately to photographer or other provider for reproductions. **The Museum does not guarantee the image quality of its historic photos. The Museum cannot refund photo processing fees.**
3. User agrees that the Museum will retain ownership of all negatives. Any copy negatives generated to fill an order will be returned to the Museum.
4. User agrees to give full recognition to the Museum for materials used in any publication, media production, or public display. A credit line must appear as follows:  
***COURTESY OF THE ARCHIVES, PASADENA MUSEUM OF HISTORY***
5. Image may not be cropped, resized or altered in any way without permission of the Museum.
6. The user will furnish the Museum with one copy, without charge, of the publication or media production in which reproductions of the Museum's materials appear.
7. Permission for in-house duplication is solely at the discretion of the Archivist. Appropriate use fees will apply.
8. The Museum's physical ownership of the materials in its collections does not imply ownership of copyright. It is the user's responsibility to resolve any copyright issues related to the use and distribution of reproduced materials.
9. Each additional re-use of reproductions requires a new application. Unauthorized reproduction of Museum materials is prohibited.
10. Original Museum materials cannot be borrowed for reproduction under any circumstances.
