In exchange for the one-time, non-exclusive use of reproductions of materials owned by Pasadena Museum of History, the user agrees to the following terms and conditions:

4. The user will furnish the Museum with one copy, without charge, of the publication or media production in which reproductions of the Museum's materials appear.
5. Permission for in-house duplication is solely at the discretion of the Archivist. Appropriate use fees will apply.
6. Museum does not assume copyrights of the material. It is the user's responsibility to resolve any copyright issues related to the use and distribution of reproduced materials.
7. Each additional re-use of reproductions requires a new application. Unauthorized reproduction of Museum materials is prohibited.
8. Original Museum materials cannot be borrowed for reproduction under any circumstances.
